



This Code of Conduct applies to all members as well as any Competitor, Driver, Pit Crew, Race Personnel, Parents of drivers and family members supporting competitors at race events.

## **PURPOSE**

The purpose of this Code of Conduct is the promotion of an atmosphere amongst the members of WA Excel Cup which encourages good sportsmanship, consideration and respect for others.

## **POLICY STATEMENT**

Members of the association shall:

- Not, by written, spoken or electronic word or by action bring the Club into disrepute.
- Respect the rights, dignity and worth of all persons regardless of their gender, abilities, religion or cultural background.
- Use their best endeavours to promote WA Excel Cup.
- Read, understand and follow the rules
- Treat all drivers and officials as they would like to be treated
- Be prepared to take responsibility for their actions

## **SOCIAL NETWORKING**

Derogatory and offensive comments made on social networks such as Facebook, Twitter, Text message and any future technologies as they become available, can bring members into disrepute. The WA Excel Cup. Inc. Association will look on this unfavorably and may impose disciplinary action.

## **DRIVING AND BEHAVIOUR STANDARDS**

If a member, driver or competitor of this Association believes that the driving and/or behavior of another competitor and/or driver and/or member of their pit crew and/or race personnel is, in their opinion offensive, physical, threatening, unsporting and/or unprofessional, then that member, driver or competitor has an obligation to submit the details of the incident, in writing (by way of letter, fax/electronic transmission) no later than the end of the seventh (7) day following the event, to the Association Secretary for consideration of the committee who may impose disciplinary action.

Any incident forwarded to the Secretary should include (if available):

- Any official documentation or reports from the Event Officials.
- Eye Witness accounts in writing and signed.
- Any race video footage of incident/s from vehicles involved or any surrounding vehicles.

If a member, driver, competitor and/or member of their pit crew and/or race personnel, of this Association, is brought before the Stewards, Race Secretary or any Official at a Race Meeting, with regards to their driving standards, or behavior, that includes offensive, physical, threatening, unsporting and/or unprofessional, the Association Committee may also decide to investigate the incident/s and impose disciplinary action, regardless of any penalties which may or may not be imposed by CAMS and/or the Race Meeting Officials.

## **COMMITTEE DECISION PROCESS**

Upon receipt of a written and signed complaint to the Association Secretary, (by way of letter, fax, electronic transmission) from a member, driver, competitor or club/event officials or at the Committees own discretion, the Secretary shall bring the matter up for discussion at the next Committee meeting and if the Committee decides (on a majority vote) that a member has refused or neglected to comply with the Association Rules, the Committee may by resolution impose one (1) or more disciplinary actions.

If a member, driver or competitor receives any disciplinary action, the member, driver or competitor shall receive, in writing, as soon as practicable, a notice from the Association stating the date of the ruling along with details of the disciplinary actions.
